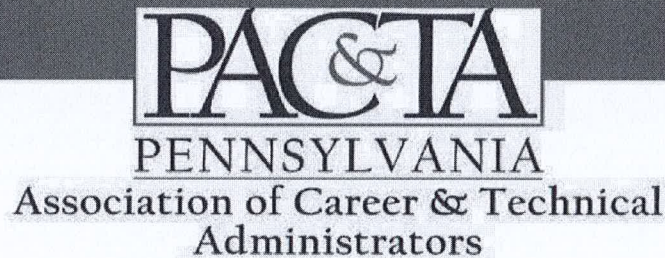

Applications must be postmarked by Friday, March 29, 2024.

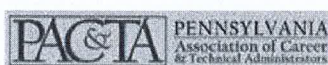
